

MEMORANDUM of UNDERSTANDING

The Vancouver Fire Department ("VFD"), the Fire Marshal's Office Bargaining Unit of IAFF Local 452 ("Local 452"), the Vancouver Police Department ("VPD"), the Vancouver Police Officers Guild ("VPOG"), the Department of Development Review Services ("DRS"), OPEIU Local 11 ("Local 11"), and U.A. Local 290 ("Local 290") enter into this Memorandum of Understanding ("MOU"), regarding the enforcement of Vancouver Municipal Code ("VMC") § 16.04.150, Amendment to IFC Section 503, and Wash. Revised Code §§ 46.61.570(1)(b)(ii), (v).

VMC § 16.04.150 prohibits parking in fire lanes on public and private property; and Wash. Revised Code §§ 46.61.570(1)(b)(ii), (v) prohibit parking within certain distances of fire hydrants and fire stations.

Members of Local 452, VPOG, Local 11, and Local 290 agree that Deputy Fire Marshals in the Fire Marshal's Office and Parking Enforcement Department shall have exclusive authority to issue Notice of Civil Violation and Orders to enforce VMC § 16.04.150; and that Deputy Fire Marshals of Local 452 and VPOG, Local 11 shall have the authority to issue parking infraction notices for violations of Wash. Revised Code §§ 46.61.570(1)(b)(ii), (v). The Fire Marshal's Office, Deputy Fire Marshal's shall be the primary point of contact for public complaints and enforcement/compliance matters. The Fire Marshal's Office; Deputy Fire Marshal's shall exclusively enforce fire lane violators after normal business hours and on weekends.

The Fire Chief hereby delegates authority to parking enforcement officers to issue Notice of Civil Violation and Orders to enforce VMC § 16.04.150; and members of VPOG, Local 1, Local 290 agree that Deputy Fire Marshal's in the Fire Marshal's Office shall receive a limited commission under VMC § 2.20.030 for the purpose of writing parking infraction notices for violations of Wash. Revised Code §§ 46.61.570(1)(b)(ii), (v).

This agreement is in pursuant to RCW Chapter 41.56.
